Application must be accompanied by <u>non-refundable \$300 Downpayment</u>. The fee will be applied toward dues once membership is approved. Applicants may pay dues in full with application or they may sign up for monthly payment via electronic fund transfer (EFT) If application for membership is accepted, the applicant agrees to pay dues for the entire membership year (April 2024—March 2025). The Wildwood Board of Trustees may, at its discretion, pro-rate the dues of the first membership year if application is approved after April 30, 2024. All Golf and Social Memberships are subject to \$75 per quarter Clubhouse minimum spending that includes both food and beverage purchases. The monthly fees noted above assume the \$300 Downpayment is applied and that the EFT is spread over 11 equal payments. The monthly fee will be adjusted to include the tax and capital improvement fees, and to accommodate for fewer payments or in the case where the member chooses to pay more up front. The EFT option is not a monthly membership option. It is a monthly payment plan for an annual membership. A photo copy of an applicant's driver's license must accompany all applications. \*\$50 Membership Equity Fee (\$500 Total, \$50 per year) \$750 Capital Fee for returning golf members who have not been a golf member for one (1) year or longer, unless they maintained a Social Membership.
